Introduction

On December 4 and 5, 2023, the sixteenth edition of the Latin American and Caribbean Internet Governance Forum (LACIGF) was held at the Externado University of Colombia, in the city of Bogota, Colombia.

The Latin American and Caribbean Internet Governance Forum (LACIGF) is a multistakeholder initiative focused on Internet governance issues and digital policies from a



regional perspective created in 2008. Its mission is to provide a space for open policy dialogue on issues within its scope, where all stakeholders participate on an equal footing without discrimination of any kind. Since its inception it has met annually in an event that to date has 16 editions.

Multi-Stakeholder Committee

The Multi-Stakeholder Committee CMPI, formerly known as the Program Committee, is responsible for the strategic and operational direction of the mechanisms that make up the LACIGF and for ensuring the proper functioning and fulfillment of its mission.

The CMPI is composed of 12 persons who are appointed 3 by each of the following stakeholder groups:

- Regional organizations representing the private sector
- Latin American and Caribbean government representatives
- Civil society organizations
- Regional organizations representing the technical community

Each sector plans its own course of action and selects its representatives based on its own criteria.

Additionally, during 2023 a new LACIGF Secretariat was appointed, a role that until June of this year had been carried out by LACNIC - <u>www.lacnic.net</u> - and that as of July 2023 was assumed by Colnodo - <u>www.colnodo.apc.org</u> -, a Colombian non-profit organization that was selected after a call process to fill this role.

Topic selection

For the selection of topics, an open consultation was conducted with the community through the LACIGF website - www.lacigf.org - in which 145 people participated, who selected in order of relevance the following topics:

- 1. Data governance and trust
- 2. Inclusion and digital divide
- 3. Cybersecurity, cybercrime and online security
- 4. Global Digital Governance and Cooperation
- 5. Al and Emerging Technologies
- 6. Avoiding Internet Fragmentation

These topics were taken into account when defining the sessions for the annual event.

Agenda of the event

The event was developed in a hybrid format, face-to-face and virtual, for the realization of six (6) panels on the topics prioritized by the community, one (1) panel on the LACIGF and the new statutes, one (1) panel on national and regional Internet Governance Initiatives (NRIs).

In addition, there was a session in which Carol Roach, chair of the Internet Governance Forum's multi-stakeholder advisory group, gave a presentation on the global Internet Governance Forum and the challenges for the region.

More than 50 panelists and moderators participated in the panels, both in person and virtually.




